2. To avoid inconvenience and expense incident to the assembling of the Brigade Staff, Regimental Field, Staff, N. C. Staff and Hospital Corps at their respective headquarters, they are authorized to report to the inspecting officer at the company station nearest their homes on the dates set for the inspection there. Transportation for the necessary travel in this connection should be obtained in time by application to these headquarters.

3. The annual inspection of the Minnesota National Guard prescribed by Section 1079, Military Code, Revised Laws of Minnesota 1905, and of all public property and funds in hands of troops will be made also at the time and place specified in Paragraph 1, for the War Department inspection by Lieutenant-Colonel William Gerlach, Inspector (Sec. 1047, M. C., R. L. M. 1905). The provisions of Section 1079, Revised Laws Minnesota, 1905, will be strictly complied with; especial care should be taken by the commanding officers of the various organizations inspected in preparing the inspection roll prescribed by law, Paragraphs 1319, 1321, 1322 and 1326 Regulations M. N. G., should be carefully observed.

A list of all absentees, showing duration and cause of absence with authority therefor, should be handed the inspector with the inspection roll, or immediately upon the conclusion of the inspection.

4. Only one copy of last annual property return need be prepared and handed to the inspecting officer, with memorandum showing changes, if any, to date of inspection. Every officer accountable for property should take an exact inventory of the same shortly before the day set for the inspection, separating articles worn out or no longer needed from the rest. Duplicate lists of such property will then be prepared and handed to the inspector in due time, who will review the property and forward both lists with his recommendations endorsed thereon to these headquarters for the action of the Adjutant General. One of the lists will be returned with directions for the final disposition of the articles inspected, to the officer accountable, and will be his voucher to account for the property on his next return.

GENERAL ORDERS  
No. 5.

1. The organizations of the National Guard named below will assemble at Camp Lakeview, near Lake City, Minn., for a ten days' tour of duty and instruction as hereinafter designated.

Third Infantry—Colonel Charles A. Van Duzee commanding, Monday June 17th, ending Wednesday June 26th.

First Infantry—Colonel Charles McC. Reeve commanding, Monday July 8th, ending Wednesday July 17th.

Second Infantry—Colonel Arthur W. Wright commanding, Thursday July 18th, ending Saturday July 27th.

First Battalion of Artillery—Major George C. Lambert commanding, Saturday July 6th, ending Monday July 15th.

2. Brigadier General Fred B. Wood, Adjutant General, is charged with the execution of this order, and for that purpose will, accompanied by general headquarters, proceed to and remain at Camp Lakeview while troops are in camp. All official correspondence should be addressed to Camp Lakeview.

3. The following named officers are ordered into service during the encampment of the several organizations of the Minnesota National Guard, as stated in Paragraph 1:

Brigadier General Fred B. Wood, Adjutant General and Disbursing Officer; Major Charles W. Fisher, Assistant Inspector General; Major Edward W. Bird, Assistant Judge Advocate General; Captain William H. Hart, Brigade Quartermaster; Captain William H. Hatcher, Military Storekeeper, and Captain Orris E. Lec, Brigade Inspector of Small Arms Practice.

Major Fisher, Major Bird, Captain Hart, Captain Hatcher, and Captain Lee will report to the Adjutant General for duty in connection with their respective departments.

4. The Adjutant General will prepare the grounds and also procure and furnish the transportation and pay necessary to the execution of all orders.

5. For purpose of instruction, regimental quartermasters and commissaries will make consolidated requisitions to these headquarters for supplies pertaining to their respective departments while in camp.

6. The Commanding Officer of the First Artillery will send one gun to camp in charge of three competent men, on the 15th day of June 1907, together with the necessary ammunition for salute firing. This detachment will report to the commanding officer of the camp for the time being, and when not engaged in artillery duty will be ordered to report to Captain William H. Hatcher, Military Storekeeper, for work in his department.

7. The senior medical officer on duty with each regiment and with the battalion of artillery will within ten days after the close of his tour of

duty, make report in writing of his observations to the regimental commander and also to the surgeon general, who with his remarks and conclusions endorsed thereon will forward the same to these headquarters.

8. The taking of "substitutes" is strictly prohibited, and regimental commanders will prosecute violations of this provision.

9. The commanding officer of each regiment will assume general charge of the camp and be responsible for its appearance during the time his command shall occupy it, and leave the same in perfect sanitary condition.

10. Enlisted men are strictly prohibited from boarding or interfering with trains stopping at or passing through the camp grounds, unless provided with proper transportation. Regimental commanders will cause charges to be preferred against any members of their command who violate this order.

11. Driving nails in tent poles, defacing tent walls or other public property will not be tolerated. Officers or enlisted men occupying tents or using public property will be held responsible for the proper care thereof, and any damage thereto will be deducted from their per diem in camp.

12. In case of accidents or wounds, and in case of serious damage to property, the commanding officer of the camp will at once make report thereof direct to the Adjutant General. He will also without further instructions, immediately convene a board of officers to ascertain and determine the injury or damage and to fix the responsibility and forward the report of the board with his conclusions thereon, as soon as practicable, to the Adjutant General.

13. Company commanders will make daily reports to regimental headquarters immediately after the morning roll call, using the Regular Army Morning Report books, and commanding officers at camp will render to these headquarters direct, a consolidated morning report of their command on each day.

14. Regimental commanders using blank ammunition in drill, will instruct their men to save the empty shells and turn the same over to the ordnance officer.

15. A general report from each regimental commander, the commanding officer of the battalion of artillery and the surgeon general, will be made to the Adjutant General within thirty days from the close of their encampment.

The following regulations relative to the conducting of small arms gallery practice by the Minnesota National Guard are hereby established and published for the information of all concerned:

1. The current season for gallery practice will open Nov. 1st, 1907, and close April 30th, 1908.
2. Practice with the 22 cal. rifle will be required of every officer and enlisted man in the infantry arm of the service (except regimental bands and hospital corps), who has not qualified as marksman, sharpshooter or expert rifleman.
3. The "Y" target will be used at a distance of 50 feet.
4. Firing will be conducted in the standing, sitting or kneeling and prone positions in scores of five shots each, and only one score will be fired on each target and the target will be the official score and filed for record.
5. All who have fired two or more full scores in the standing, sitting or kneeling and prone positions, and from the best two scores in each position have attained an aggregate of 120, will be classified as gallery marksmen and entitled to the State decoration as such.
6. The amount of practice required for each individual will be determined by company commanders, and the rules as prescribed in Firing Regulations for small arms practice will govern all points not covered by this order.
7. All scores to be considered and computed in arranging classification must be filed with the company commander, giving full name and rank of officer or enlisted man and date on which score was made.

At the close of the gallery practice season company commanders will forward all qualifying scores to the Brigade Inspector of Small Arms Practice.

*The Adjutant General:*

Sir: I have the honor to submit herewith report of small arms practice of the Minnesota National Guard for 1907. In connection therewith, I beg leave to invite attention to the standing of the various organizations which shows a general reduction in figure of merit. There are honorable exceptions clearly traceable to diligent work at home stations both in gallery practice and on outdoor ranges, wherever this appears scores are higher and more decorations have been earned. I cannot too strongly recommend that company commanders be urged and required to pay more attention to instruction in rifle practice during the winter and spring before going to camp. This is certainly not asking too much in view of the measures taken by you during the past year to furnish all the troops with reduced caliber rifles and ammunition for gallery practice and increased allowance of ball cartridges for range work. Even where company commanders find it utterly impossible to get an outdoor range, much of the preliminary instruction necessary to assure good results at camp can be imparted if they will develop a reasonable degree of enthusiasm for this commendable work.
