# MERIT ARMY NATIONAL GUARD ACTIVE GUARD RESERVE (AGR) VACANCY ANNOUNCEMENT ARNG 25-293

**SELECTING OFFICIAL:** CPT Miranda Decker

WHO MAY APPLY: Current members of the MN ARNG serving on AGR or as T32 Technician, in the rank of SGT/E-5 to SSG/E-6. Must have or be able to obtain 13F MOS. Eligibility is limited to personnel currently in the Minnesota Army National Guard who are serving on an Active Guard/Reserve (AGR) tour or as a T32 Technician. Current AGRs must have a minimum of 18 months in the program to be eligible for reassignment. If a current Technician is selected, they will be accessed into the AGR program.

**REMARKS: PCS for current AGR's depends on funding.** Upon selection, individual must be or become MOS/AOC qualified within twelve (12) months of appointment, except for deployed Soldiers, who will have an additional 12 months.

**DUTIES AND RESPONSIBILITIES:** This position is located at the unit level. Must be able to successfully pass Bradley Master Gunner Course 020-ASIJ3 or previously been awarded the ASI J3 Bradley Fighting Vehicle Master Gunner. Assists in carrying out the plans and programs established by the chain of command for the accomplishment of the unit training objectives and missions. Functions as the company technical advisor for all training items IAW Combined Arms Training Strategies, TC 3-09.8, and TC 3-20.31. Responsible for developing and implementing the Fire Support Certification and Radar Certification within the unit through Table VI. Performs duties as the Company level Bradley Master Gunner and assists the Battalion Field Artillery Master Gunner in developing collective training exercises. Certifies gunnery skills test evaluators IAW TC 3-20.31. Trains Vehicle Crew Evaluator's within the BN. Submits schools applications, orders, funding, and Defense Travel System (DTS) Authorizations/Vouchers and verifies for completeness and accuracy. Maintains the unit training files and libraries. Prepares and submits requests for training areas and ranges. Assists the Readiness NCO in obtaining/maintaining mobilization readiness of the unit. Coordinates closely with the Detachment OIC and NCOIC in developing, implementing, monitoring and evaluating the unit's individual training programs and records, training schedules, and training assessments in accordance with Digital Training Management System (DTMS) guidance/standards. Performs duties as unit security manager and assist with Master Driver duties. Completes cross training by becoming familiar with and occasionally performing duties of other full-time support positions assigned to the unit. Receives technical guidance from the Battalion Operations Sergeant. Performs other duties as assigned or required. Must be DMOS qualified within the period prescribed in NGR 600-5.

**LENGTH OF TOUR: 3 YEARS –** Subject to program continuance; members successfully completing initial tour will be afforded priority for tour extension, after completing initial tour.

**AGR PROGRAM BENEFITS:** Salary is determined by military grade and time in service. Member is authorized Subsistence allowance, Basic Allowance for Housing (BAH), thirty (30) days annual leave; medical and dental care. TRICARE Prime Remote or TRICARE Standard coverage for dependents. Military Exchange and Commissary privileges.

#### AGR PROGRAM MINIMUM QUALIFICATION REQUIREMENTS

- 1. Must be a member or eligible to become a member of the Minnesota Army National Guard. Selected individual must extend/enlist for a period equal to the AGR tour.
- 2. Must meet medical standards prescribed by AR 40-501, Chapter 3 and physical standards prescribed by AR 600-9. Soldier must have a favorable Periodic Health Assessment (PHA) in accordance with (IAW) AR 40-501, chapter 3 conducted within 12 months prior to initial entry into the AGR Program. Soldier must have a Human

Immunodeficiency Virus (HIV) test within the last 24 months prior to initial entry into the AGR program IAW AR 600-110. This examination is to be accomplished at an active military medical treatment facility, an ARNG medical unit, US Army Reserve medical units, or a civilian medical facility.

- 3. The individual must be eligible to complete a minimum of five (5) years in AGR status immediately prior to his/her mandatory separation date or prior to completing 18 years of Active Federal Service.
- 4. Individual must not be eligible for, nor receiving a federal military retired or retainer pay, nor federal service annuities.
- 5. Individual must possess or be able to obtain appropriate security clearance.
- 6. Must not be a candidate for elective office, holding a civil office (full or part-time), or engage in partisan political activities as defined by DoD Directive 5500.7, Joint Ethics Regulation.
- 7. Applicant selected will be subject to State Military Justice procedures/statutes and State Civil Laws/statutes, as appropriate, when serving under provisions of Title 32 U.S.C.
- 8. Applicant must meet other eligibility requirements for AGR service under the provisions of AR 135-18 and NGR 600-5

#### How to combine PDF into one document

## -All digitally signed documents must be printed to PDF before merged. Signatures can be lost in merge and will not be accepted

- -Right click your first document, and select "Edit with Adobe Acrobat"
